CONVOCATION ADDRESS BY THE PRESIDENT

"The Bar must continue to honour its objectives of maintaining the honour and the independence of the Bar and the Judiciary."

I thank you all for your presence at the Convocation today, which we are compelled to hold in a manner different from the traditional Convocation so as to comply with the health guidelines in the

face of the pandemic. I am honoured by the presence of the Justices of the Supreme Court and the Court of Appeal at this Convocation.

I must at the outset thank Mr. Kalinga Indatissa PC the outgoing President of the BASL for his life time of service to the Bar. I will value the advice of Mr. Indatissa and all Past Presidents of the Association and of the Seniors of the Bar.

I am deeply honoured by the confidence placed in me by the Bar, in electing me as the President of the Bar Association of Sri Lanka, an integral part of every democracy especially in upholding the Rule of Law. We managed to streamline the appointment of President's Counsels. We did not hesitate to invoke the jurisdiction of the highest Court in this land in respect of the power of the Executive to grant presidential pardons and on matters relating to accountability in respect of national security.

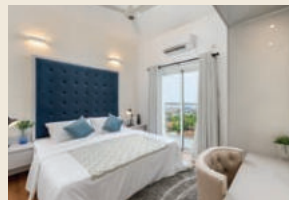

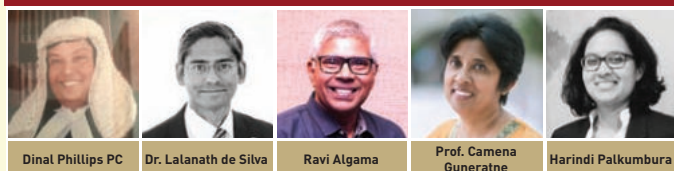
THE MANAGEMENT COMMITTEE ASSUMES DUTIES

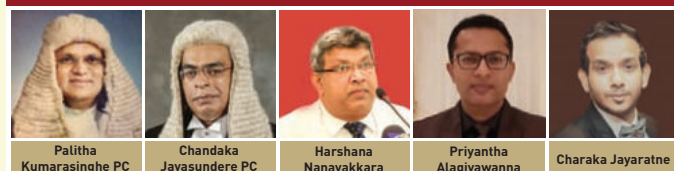

CONVOCATION ADDRESS BY THE PRESIDENT

I am humbled by the support and strength I received from the members of the Bar across the country and from both the senior and junior members of the Bar, in what was a tumultuous election campaign. This year's election saw the highest turn out ever in the history of the Bar. It is a testament to the Bar's dedication to the Rule of Law, the Independence of the Judiciary and to the common values we share.

I am indebted to all those members of the Bar who dedicated themselves in many ways to secure my victory. I thank Dr. K. Kanag Iswaran PC, Mr. Faisz Musthapha PC, Mr. Rienze Arseculeratne PC, Mr. Palitha Fernando PC, Mr. Anil Silva PC, Professor Mrs. Wasantha Seneviratne who were my proposers and also to Mr. Sanjaya Gamage AAL, Mrs. Shiranthi Gunewardena AAL, Mr. Hemaka Senanayake AAL, Mr. Rasika Dissanayake AAL, Mr. Sanath Wijewardena AAL and Mr. Shivan Coorey AAL who seconded my nomination. I must also thank many seniors including Mr. Ikram Mohamed PC and Mr. Geoffrey Alagaratnam PC who gave me strength and support during this time.

I will do everything within my capacity to honour the confidence and trust that you have placed in me. I am also aware that I am bound to serve all members of the Bar and I am conscious that I have drawn support from a wide cross section of the Bar. I believe in a Bar which is united and I believe we must look to the factors which unite us rather than to those factors which tend to divide and separate us. A united and strong Bar is essential for the strength of this Association.

I am conscious of the role which the President of the Bar is required to play. The Bar must continue to honour its objectives of maintaining the honour and the independence of the Bar and the Judiciary. While maintaining its independence it is also necessary for the Bar to be non-partisan and to take its decisions based on policies and principles.

I am committed to the objectives of the Bar Association, amongst which are the upholding of the Rule of Law, Safeguarding the Independence of the Judiciary and fostering the fundamental rights of the people of Sri Lanka. The promotion, observance and protection of human rights and liberties including the right of access to courts are an essential component of the Rule of Law and are among the objectives of the BASL.

It is in this spirit that for many years the Legal Aid Foundation of the BASL handled cases of detainees in order to secure their rights. In my view the BASL must play a positive role in respect of the Fundamental Rights of the people including rights which are of public importance such as the freedom of expression which is the foundation of all other rights, as well as environmental rights.

In its 1968 publication titled the Rule of Law and Human Rights, the International Commission of Jurists observed that "in a free

society practicing the Rule of Law, it is essential that the absolute independence of the judiciary be guaranteed. Members of the legal profession in any country, have over and above their ordinary duties as citizens, a special duty to seek ways and means of securing in their own country, the maximum degree of independence for the judiciary".

The Bar will continue to be committed to ensuring to a maximum degree the Independence of the judiciary and to seek ways and means by which the Independence of the judiciary can not only be safeguarded but also be enhanced. The Bar should not hesitate to let its views be known whenever the Rule of Law or the independence of the judiciary is imperilled. In fact the objectives of the BASL require the intervention of the Bar in situations of national importance whenever the Rule of Law or the administration of justice is affected.

In this context the BASL needs to continue to examine and make representations to the State on how best the independence of the judiciary should be safeguarded. In this context the principled position taken by the Bar Council during the passage of the 20th Amendment Bill is noteworthy. The manner of Judicial appointments, the need to secure checks and balances in the powers of appointment of the judiciary, the need for greater openness and transparency in judicial appointments, the need for a proper process for removal of judges in terms of the Latimer House principles, the need to strengthen the independence and integrity of institutions in Sri Lanka including the Commissions such as the Bribery Commission and the Human Rights Commission, powers of Commissions of Inquiry in respect of ongoing cases, are all matters which must be carefully scrutinized by the Bar, keeping in mind its primary objective.

Whilst the Bar seeks to safeguard the Independence of the Judiciary it is equally important to the Rule of Law that the rights and privileges of the Bar be secured. The support of the Judiciary at all levels in securing the rights and privileges of lawyers is essential.

On the 31st July 1964, during his farewell address Chief Justice Basnayake Q.C. observed as follows:

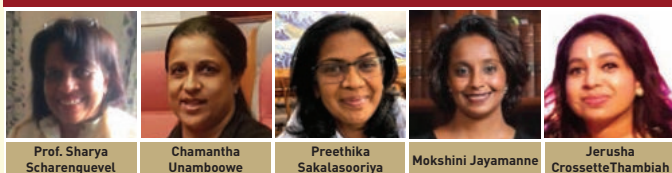
"Under our system of justice, the Bench and the Bar are components of one unit. The impairment of one inevitably affects the other. It behoves the bench, therefore to uphold the rights and privileges of the Bar, and the Bar to guard the prestige and sanctity of the Bench..."

In relation to the Independence of the Bar and the rights and privileges of its members, it is necessary to safeguard and strengthen the rights of Attorneys-at-Law in different spheres.

We have completed over sixty Webinars in the past ten months, and a special feature was that we had over 200 Lawyers as Resource Persons for these two series, and this is probably a first as well. This was supplemented by the six Online Certificate Courses where we trained close to 1,000 participants and we generated the highest revenue of Rs. 11.4 Million from these Programmes which kept the BASL financially stable during these difficult times.

Consequently, we did not have to cut down on BASL staff, or reduce pay, and in fact, we just granted a bonus to all the staff as well. Looking back, we managed to overcome the difficulties and constraints and have a year as normal as possible for the BASL.

We had the National Law Conference in a hybrid form this year, which was also acclaimed as one of the best, we had two Legal Symposiums, a Provincial Law Conference, several Workshops and we also Chartered a Toastmasters Club. Then we had so much co-ordination and new activity due to COVID, from assisting and supporting members who were infected to securing permission to use the BASL ID Card as a Curfew Pass and most recently commencing a vaccination programme, and the list goes on.

We also were able to publish two Newsletters. So overall, we have had a very good year, and this would not have been possible if not for the excellent Management Committee we had, the President Mr. Kalinga Indatissa, PC led the Association during two very turbulent years and did his very best and kept the BASL flag flying high, Deputy President Mr. Shavindra Fernando, PC, Treasurer Mr. Nalin De Silva and Assistant Secretary Mr. Pasindu Silva supported and gave leadership to all the initiatives and activities to their fullest. The Executive Committee also was very involved and engaged and I thank them very much.

I take this opportunity to thank our Chief Guest, Chief Justice His Lordship Jayantha Jayasuriya, PC for all the support and guidance given to the Bar and for being our Chief Guest today. I must also thank the Minister of Justice, Hon. M.U.M. Ali Sabry, PC for gracing this occasion and for all the good work being done through the Ministry. Also, I must thank the Hon. Attorney General Dappula De Livera, PC and the Hon. Acting Solicitor General Sanjaya Rajaratnam, PC for being present today and for officiating at both the Bar Council and the formalities at this function.

I also thank the Hon. Judges of the Supreme Court, the Hon. President of the Court of Appeal Lordship Justice Arjuna Obeyesekere, and the other Hon. Judges of the Court of Appeal for your distinguished presence today.

Congratulations to new President of the Bar Association of Sri Lanka Mr. Saliya Pieris, PC, the new Deputy President Mr. Anura Meddegoda, PC and the new Treasurer Mr. Rajindh Perera and I look forward very much to work with you in the coming year towards raising the Bar. I also congratulate all the members of the Executive Committee for 2021 / 2022, and also all the Zonal Vice Presidents. I look forward to working with all of you.

A special word of thanks to the BASL Staff led by our CEO Mrs. Suranee Samarasekera for all the hard work done, not only for today's event, but for all the support given to me in the last year. I must also thank all other service providers, and also our excellent comperes Attorneys-at-Law Mr. Shehan Gunawardena and Ms. Sonali Wanigabaduge.

Before I conclude, I would like to thank my Senior and Uncle Mr. Sanjeeva Jayawardena, PC and my Late Uncle Justice Prasanna Jayawardena, PC for being my mentors right throughout and the guidance given to me, which was invaluable in performing my role as the Secretary.

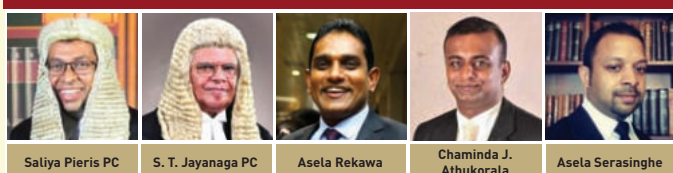

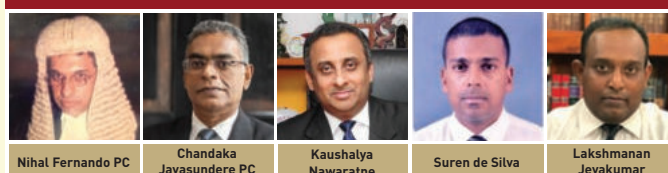

APPOINTMENT OF NEW ATTORNEY GENERAL, MR. SANJAY RAJARATNAM PC

Mr. Sanjay Rajaratnam PC was appointed as the Hon. Attorney General on 26th May 2021 by His Excellency the President.

Releasing a statement in this regard, the BASL whilst congratulating the new Attorney General, expressed confidence that he will exercise his duties impartially and maintain the independence of the Office of the Attorney General. It was also noted that at the time of his appointment as the Attorney-General, Mr. Sanjay Rajaratnam PC was the Acting Solicitor-General and the most senior officer in the Department of the Attorney General presently eligible for appointment, having served the Department of the Attorney-General since 1988.

Further, the BASL commended His Excellency the President and the Parliamentary Council for giving due consideration to merit and seniority of service in the Attorney-General's Department and other vital criteria when appointing the Attorney-General on the first occasion of such an appointment made after the enactment of the 20th Amendment of the Constitution.

The BASL also thanked the outgoing Hon. Attorney-General, Mr. Dappula de Livera PC, for his service to the Department and the co-operation he extended to the BASL during his tenure.

UNVEILING OF THE PORTRAIT OF THE IMMEDIATE PAST PRESIDENT

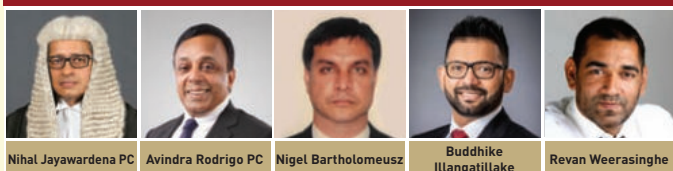

Mr. Kalinga Indatissa PC shared some heartfelt sentiments with the audience at this occasion.

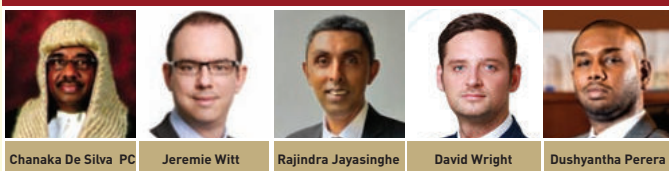

BASL EXTENDS SUPPORT TO THE MOJ PROGRAMME - “එන්න හිතෙන උසාවියක්”

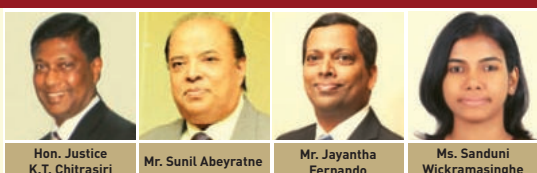
The BASL has been constantly in discussion with the Ministry of Justice (MOJ) informing them of the needs of the Court houses across the country. Under this phase, Officials of the Ministry will visit Court Houses in relevant areas and meet with the Court Officials and the BASL Branch

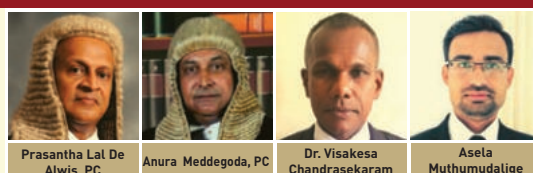
Office Bearers to identify areas for improvement and issue faced by them in the discharge of their professional duties.

A SUMMARY OF ACTION TAKEN BY THE BASL IN THE WAKE OF THE 3rd WAVE OF THE COVID-19 PANDEMIC

1. RESUMPTION OF COURTS

The BASL having identified the urgent and vital need of the resumption of Court and Court operations (complying with health guidelines) amidst travel restrictions in force, on 8th June 2021 submitted detailed proposals to the Judicial Services Commission, seeking that arrangements be made for the Courts to function in terms of the health guidelines issued by the relevant authorities. The first part of the proposals relates to the functioning of Courts amidst travel restrictions and the second relates to pertains to functioning of Courts when travel restrictions are eased.

These proposals of the BASL were prepared after consultation Branch Associations and considering that the Government Circulars imposing travel restrictions have recognized Courts of Law as an essential service.

Inter alia, these proposals included:

1. To give discretion to the Judges in different areas on the functioning of Courts in consultation with the local Bar and the health authorities.
2. Provide transportation facilities to Court staff to enable resumption of Court work.
3. Whenever possible, to use technology for the purpose of Court work.

Thereafter on 15th June 2021, the members of the Management Committee of the BASL met with His Lordship the Chief Justice and others members of the Judicial Services Commission for a discussion pertaining to the resumption of Courts and to explain the said detailed proposals submitted by the BASL which were received positively. The Hon. Attorney General and the Senior Additional Solicitor General Indika Demuni De Silva, PC also joined this meeting at the request of the BASL.

The BASL during this time period also made representations to the Hon. Minister of Justice on providing transport for Court Staff and on the use of technology in Courts.

2. LAUNCH OF COVID – 19 HELPLINE FOR MEMBERS

A COVID-19 Helpline was launched by the BASL on 29th April 2021 for the membership where members who needed support could contact the BASL 24/7. Through this helpline, many members and their families were assisted during this pandemic period in several ways, including finding of treatment facilities, finding necessary drugs from private sector and facilitation of other treatments through the authorities for certain members whose health conditions became

serious and facilitating family members of the condition of their loved ones, when they were unable to obtain information.

The BASL extends its thanks to the Chairman of the BASL COVID-19 and Emergency Situation Response Committee, Mr. Lasitha Kanuwanaarachchi, the Co-Chair Mr. Tenny Fernando, Convenor Mr. Tharindu Rajakaruna, Co-Convenor Mr. Ramzeen Bacha, the Committee Members and Mr. Prakalathan Thuraisingham of the BASL Programmes Committee for the hard work put in for an effective response mechanism at the BASL.



4. VACCINATION PROGRAMME

The BASL made several representations to relevant Authorities of the need to inoculate the membership in order to facilitate resumption of court work which is an essential service. With positive feedback, the BASL facilitated the provision of COVID-19 vaccines for its members through the BASL and its Branches and this facilitation included the second dose of the Astra Zeneca vaccine (for the members who got the first dose at the Army Hospital), assisting in the provision of the Sinopharm vaccine by collection of data (through Google form) of members that are in need of the same and coordination with Authorities to provide the same and direct coordination and facilitation with authorities on behalf of many Branch Associations to conduct inoculation programmes at the relevant local Bar areas itself for the benefit of the members.

5. CIRCULATION OF CIRCULARS/NOTICES ISSUED BY THE JSC AND COURTS

The BASL has circulated all circulars issued by the JSC and the Superior Courts through SMS during this time. A compiled list (with previous Circulars/Notices) was also made available. In addition to this, the BASL has also circulated Circulars issued by the Registrar-General. Wherever possible the BASL has collated dates of cases re-fixed due to the COVID-19 from around the country and disseminated it to the membership.

6. TRAVELLING TO COURT

The BASL made representations on behalf of the membership to the Inspector General of Police with regard to travel of Attorneys-at-Law for essential / urgent court work during the period in which travel restrictions are in place. As a result, Attorneys-at-Law were permitted to use their BASL Identity Card for this purpose provided that they were in Court Attire when travelling. The BASL thanks the Senior Deputy Inspector General Mr. Ajith Rohana who is the Head of Legal of Sri Lanka Police and also the Co-Chairman of the BASL Police and Prisons Relations Committee in this regard.

7. REPRESENTATIONS TO THE REGISTRAR GENERAL

Representations were made to the Registrar General with regard to the payment of stamp duty and the submission of duplicates. These representations were received positively and a grace period was granted for Notaries with regards to the submission of the duplicates. The BASL thanks the Notarial Practice Committee Chairperson Ms. Shiranthi Gunawardena, Co-Chairperson Ms. C. Ellawala and Convenor Ms. Nirodha Kalansuriya.

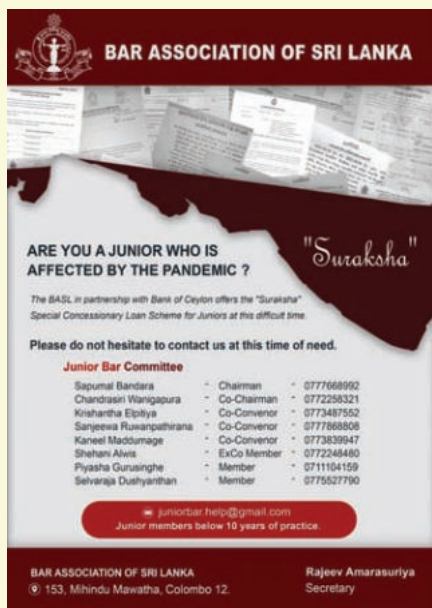

10. DONATION OF DISINFECTION CHAMBERS

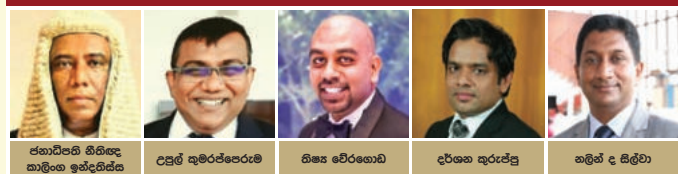

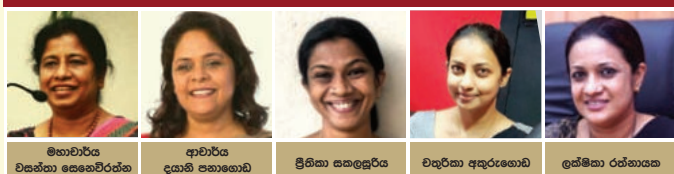

DIGITAL HEARINGS OF THE COURT OF APPEAL

Although the travel restrictions imposed since 3rd May in view of the 3rd Wave of the pandemic were lifted, the Court of Appeal for a further time period continued to entertain only a limited number of cases designated as urgent, in Open Court, in view of the guidelines issued by the Director General of Health Services at the time.

However, taking into account the amount of cases which were due to be re-fixed on fresh dates for several steps, the Court of Appeal, as an interim measure, conducted Digital Virtual Hearings (in Zoom platform) as prescribed by Court of Appeal Notice No. 23/2021. The Court of Appeal (Electronic Filing and Urgent Digital Virtual Hearings) (Special Provisions) Rules, 2021 published in the Extraordinary Gazette 2216/08 dated 23rd February 2021 formed the basis for the conducting of Digital Hearings. The BASL communicated with the membership a Notice in this regard which included the guidelines that has to be followed in Digital Hearings.

BASL ONLINE CERTIFICATE COURSES

The BASL launched the first of its Online Certificate Courses in June 2020 (the first being the Certificate Course in Commercial Arbitration) as an alternative to Physical Courses which could not be conducted due to the Covid-19 pandemic and restrictions in place, and as a means of adjusting to the new normal wherein our membership is able to engage in Continuous Professional Development despite the constraints. The Online Courses proved to be a massive success over the past year (with a total of 6 Online Certificate Courses completed) and generated a large appeal for the same particularly due to the elimination of geographical barriers in attending these Courses, which barrier was also causing difficulty to our members in outstation and abroad.

The launch of the first Online Certificate for this year was on the topic of 'Intellectual Property Law' and commenced on the 30th of April 2021 and concluded on the 30th of July 2021. Over 150 participants were enrolled for this programme and were awarded with Certificates at the successful completion of the same.

The BASL thanks Dr. Sampath Punchihewa who designed this Programme and the panel of lecturers and resource persons which included several eminent members of the legal profession including Dr. K. Kanag-Isvaran PC, Dr. Harsha Cabral PC, Mr. Dinal Phillips PC, Mr. Chandaka Jayasundera PC, Ms. Geethanjali Ranawaka (Director General of NIPO), Dr. D. M. Karunaratne (former Director General of NIPO), Prof. Naazima Kamardeen, Dr. N. S. Punchihewa, Mr. Menaka Herankaha, Dr. Darshana Sumanadasa, Mr. Chanakya Jayadeva, Dr. Chamila Talagala, and Ms. Lihini De Silva.

Thereafter, the second Online Certificate for this year (8th Overall Online Certificate Course) was launched on the topic of 'Legal Drafting' and this programme commenced on 14th July 2021 with over 440 participants. It is also noteworthy that this Online Course earned the highest ever revenue for Certificate Courses in the history of the BASL.



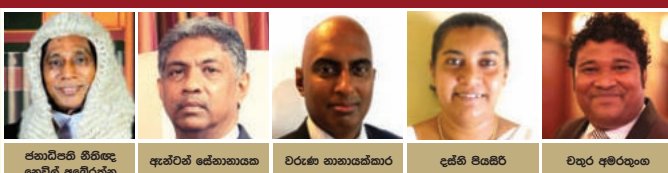

JUDGMENTS

Hondamuni Chandima Samanmalee de Zoysa Siriwardena and Another vs. Inspector Malaweera and 5 Others.

SC/FR Application No. 242/2010

Decided on 30th April 2021

B.P. Aluwihare PC, J; L.T.B. Dehideniya, J and S. Thurairaja PC, J;

FR Application - Article 11, 12(1) and 14(1)(g) of the Constitution - Police Rules 2012- Section 55 of the Police Ordinance.

Ms. Hondamuni Chandima Samanmalee de Zoysa Siriwardena (the 1st Petitioner), and Mr. Sudusinghe Liyanage Pubudu Kumara (the 2nd Petitioner), are Attorneys-at-Law of the Supreme Court of Sri Lanka.

The facts in brief relate to the Petitioners being subject to derogatory remarks, humiliation, harassment and intimidation / threats by the 1st and 2nd Respondents (who are Police Officers) when they had visited the Amabalangoda Police Station to represent a client who had been wrongfully accused of kidnapping his grandchild by the child's father in the circumstances where there was an existing Court Order which granted the temporary custody of the child to the said Client. Threats inter alia had included action being filed against the Petitioners for offering 'wrong advice regarding the kidnapping of the child' and also of arrest of the Petitioners if the child was not produced immediately. Furthermore, further incidents of harassment and intimidation towards the 1st Petitioner has taken place after the primary incident at the Police Station.

The Supreme Court granted Leave to Proceed for the alleged violation of Fundamental Rights guaranteed under Article 12(1) and 14(1)(g) of the Constitution by the 1st-5th Respondents and also for the alleged violation of Article 11 of the Constitution by the 1st and 2nd Respondents.

S. Thurairaja PC, J allowing the Application inter alia held:

1. In the instant case, the trauma caused is a form of mental suffering inflicted intentionally by public officials in the discharge of their duties. Thus, it is imperative that such action should be condemned by this Court.
2. Treatment meted out to the Petitioners by the 1st and 2nd Respondent is a violation of their rights under Article 11 of the constitution. Further it is a violation of the Petitioners rights under Article 12 and 14 (1) (g) of the constitution as it is an interference with their freedom to engage in their occupation, particularly given that this incident was an occurrence during their exercise of duties as are demands of their occupation, in the best interest of the 1st Petitioner's Client
3. It is indeed for the sake of upholding the integrity of the entire body of police officers that we must condone incidents of misconduct such that the reputation of the police forces may not be tarnished by the misdemeanors of a few. It would be great injustice if the actions of a few were to discredit the valuable services of the dedicated and disciplined officials dutifully ensuring the safety and peace of all citizens.
4. As in the instant case, when an Attorney-at-Law acts in a reasonable, non-provocative and rational manner, unruly behavior by a police officer directed towards her is an unacceptable response.
5. In order for those of the legal profession to safeguard the dignity of their office, Police officers and other members bearing public office must be of assistance, exercising their duties by respecting codes of ethics as well as respecting the unwritten rules of human decency.

B.P. Aluwihare PC, J also allowing the Application inter alia held:

1. Article 11 of the Constitution endows every person with absolute protection from torture, or cruel, inhuman or degrading treatment or punishment. Article 12 (1) stipulates that everyone is equal before the law and is entitled to the equal protection of the law.
2. The identity or the status of the person whom the police is dealt with should have no bearing whatsoever on the fair and courteous treatment that they are entitled to, as of right. Police officers are bound to treat every person with dignity and respect.
3. The Rules (Police Rules 2012) referred to have only restated the Fundamental Rights enshrined in the Constitution and referred to them expansively with the objective of enlightening the police officers of the need to respect Fundamental Rights.
4. Police officers are required to take extra care in the discharge of their duties in view of the fact that they are endowed with coercive powers to perform their functions.

5. The conduct of the 1st and the 2nd Respondents had resulted in an infringement of Article 14 (1) (g) of the Constitution. Obstructing an Attorney-at-Law from representing or looking into the interests of a client or surrendering a client to the police, which are duties that a lawyer is professionally entitled to carry out, is certainly a violation of that right.

Suriarachchige Raju vs. Barbeyn Reef Hotel Ltd.

SC/Appeal 132/2016

Decided on 6th August 2021

B.P. Aluwihare PC, J; V.K. Malalgoda PC, L and E.A.G.R. Amarasekara J;

Industrial Dispute – Unlawful Termination – Duty to Hold Domestic Inquiry – Natural Justice – Charge Sheet on Final Incident – Could it be Taken in Isolation? – Industry Demands – Application of Just and Equitable Order – Termination Justified.

In this Appeal, the Applicant-Respondent-Petitioner [hereinafter referred to as "the Petitioner"] had been employed with the Respondent-Appellant-Respondent Hotel [hereinafter "the Respondent"], as a Chef from 1992 to 2010.

The facts in brief relate to the Petitioner having been found sleeping on 21/04/2010 whilst on duty (Further, evidence also indicated that the Petitioner had been warned on several previous instances on reporting to work late, to which disciplinary action had also been taken.). The reason attributed by the Applicant for the conduct alleged, was the aggravation of his diabetic condition. When the Petitioner reported to work on the following day, he had been served with a letter suspending him from service with effect from the said date and thereafter was served with a Charge Sheet and after a lapse of month had been terminated from service.

Petitioner went before the Labour Tribunal and the Labour Tribunal Ordered the reinstatement of the Petitioner based on the fact that the Respondent had not afforded an opportunity for the Petitioner to offer his explanation to the allegations. The Respondent thereafter appealed to the High Court which set aside the Order of the Labour Tribunal and held that the Respondent was justified in terminating the service of the Petitioner.

On appeal by Petitioner thereafter, the Supreme Court granted Leave to Appeal inter alia on the following questions:

- a) In the circumstances pleaded, is the judgment of the High Court which had dismissed the application of the applicant just and equitable in terms of law?

B.P. Aluwihare PC, J dismissing the Appeal inter alia held:

1. There is no duty to hold a domestic inquiry unless there was a special provision to do so in terms of the contract of employment or the collective agreement. It is accepted that a domestic inquiry will, however, be useful in establishing the bona fides of the employer.
2. It is generally accepted that judicial decision-making in any case, regardless of its nature, should be governed by the principles of natural justice, in order to guarantee a just decision-making process, by ensuring the right to a fair trial and avoid prejudice.
3. The Applicant had been excused and issued warning letters on 3 occasions. When he failed to mend his ways, he had been sent on compulsory leave, with the incident on 21st April finally leading to his termination. It would not be fair by the employer to consider the final incident which led to the termination, in isolation.
4. The unreasonable conduct of one party in the employer-employee relationship, should not burden the other party.
5. The employees are not only expected but are under a duty to rise up to industry demands and to act reasonably and with a sense of responsibility.
6. It is clear that equity is not sympathy and that a court is barred from reaching a just and equitable decision based solely on sympathetic considerations. A just and equitable decision in an industrial matter is one which takes into consideration the situations of both the employer and the employee and assumes a holistic approach to the issue at hand based on the existing legal framework.

BASL INTERVENTIONS ON BILLS

INTERVENTION ON THE PORT CITY ECONOMIC COMMISSION BILL

The Executive Committee of the BASL on 31st March 2021 appointed a Committee to study and make recommendations to the BASL in respect of the Colombo Port City Economic Commission Bill gazetted in Gazette Supplement Part II of March 19, 2021 issued on 24th March 2021.

The Committee was chaired by Mr. Ikram Mohamed PC and comprised of Mr. Uditha Egalahewa PC, Mr. Chandaka Jayasundera PC, Mr. Eraj De Silva, Mr. Manjuka Fernandopulle and Mr. Dhanya Gunawardena. Convenor of the Committee was Mr. Shivan Cooray and Ms. Yoshani Demuni was the Co-Convenor.

The Committee whilst noting that the proposed Bill is of national importance and can carry tremendous and significant economic benefit to the country, however in its Report recommended that the BASL challenge this Bill on the basis of the findings of Report which inter alia highlighted many issues pertaining to several Clauses / Provisions of the Bill (that made them inconsistent with several Articles of the Constitution) and also of the lack of consultation, transparency, the insufficient time granted to stakeholders to examine the Bill and its effects in detail.

At a special meeting held on 12th April 2021, the Executive Committee whilst conveying its deep appreciation to the members of the Committee, resolved to Petition the Supreme Court to challenge this Bill.

The BASL is also greatly appreciative and thank Mr. Ikram Mohomad PC and Mr. Uditha Egalahewa, PC who appeared for Mr. Saliya Pieris, PC, President BASL and Mr. Rajeev Amarasuriya, Secretary BASL (the Petitioners to the Supreme Court on behalf of the BASL), and to Mr. G.G. Arulpragasam who was the Registered Attorney-at-Law.

INTERVENTION ON THE INLAND REVENUE (AMENDMENT) BILL

Upon representation made by the Tax Committee of the BASL, the Executive Committee of the BASL were apprised of several possible unconstitutional Provisions in the 'Inland Revenue (Amendment) Bill' gazetted in Gazette Supplement Part II of March 12, 2021 issued on 18th March 2021.

Particularly Clause 40 and 47 of the said Bill appeared to violative of Articles 12(1) and 14(1)(g) of the Constitution, and if enacted would have been seriously violative and prejudicial to the rights of Professionals including Attorneys-at-Law.

Therefore, and given the inadequacy of time to place this before the Bar Council, at a special meeting held on 12th April 2021, the Executive Committee whilst conveying its deep appreciation to the members of the Tax Committee, resolved to Petition the Supreme Court to challenge this Bill.

The BASL is also greatly appreciative and thank Dr. K. Kanag-Isvaran, PC with Mr. Lakshmanan Jayakumar who appeared for Mr. Saliya Pieris, PC, President BASL and Mr. Rajeev Amarasuriya, Secretary BASL (the Petitioners to the Supreme Court on behalf of the BASL), and to Ms. Lanka Dharmasiri who was the Registered Attorney-at-Law.

The BASL is further happy to state that the offensive provisions challenged by the BASL had been duly amended.

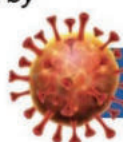

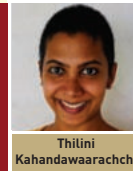

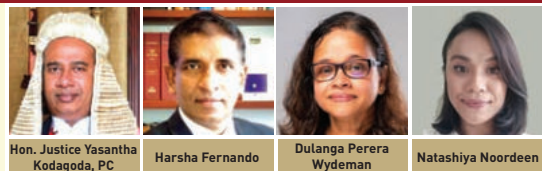
